What is happening

- YGC web-based application will **no longer be available as of April 2022**
- **vExchange** will officially replace YGC as of April 2022

YGC Existing Services

- Data Exchange
- YGC Analytics
- YGC Data Standard
 - YGC Statuses (PCODES)

What is going to be impacted?

YGC Data Standard → YGC to vExchange Business Adapter

- Senders and receivers could continue using the YGC data format.
 - Vertican has built a YGC-to-vExchange Business Adapter that will translate data to and from vExchange.
- Clients could continue using YGC pcodes
 - YGC = cc:S101 → vExchange = vX:S101
- Collection-Master, Q-LawE, and Q-Law users will be able to continue using the YGC DTP (version 3.3) to communicate with other Senders outside of vExchange.

YGC Analytics → vExchange Analytics Dashboard

- You will be able to access historical YGC data through the vExchange Dashboard.
- vExchange Analytics Dashboard allows web access to the following information:
 - Placements and Consumer/Debtor Information
 - Key Events and Records Summary
 - Legal Information and Financials
 - Disputes and Notes
 - Process Logs and Reports
 - Gates Rejections (only if the Sender is subscribing to this service)

YGC Claim Entry → Discontinued

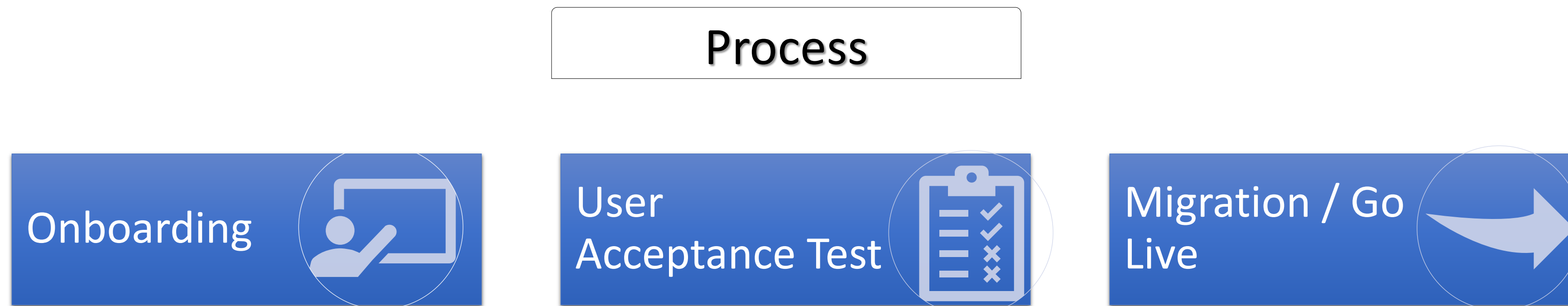

Schedule

- Onboarding all Senders and Receivers in January and February of 2022
- Vertican Implementation team will coordinate UAT during March 2022
- vExchange will officially replace YGC in April 2022

Non-VT Collection Software Users

- vPortal Account (Master Service Agreement)
 - You must establish a vPortal account and execute the user agreement.
- vExchange Mailbox
 - Complete the online Mailbox/FTP application form.
- vExchange Native Adapter or YGC Business Adapter
 - vExchange Native and YGC Business Adapter are available for purchase on vPortal.

Collection-Masters Users

- vPortal Account (Master Service Agreement)
 - You should have a vPortal account and an executed user agreement.
- vExchange Mailbox
 - Your Total Plan subscription already includes a vExchange Mailbox.
- The vExchange DTP for Collection-Master is CMvX
 - CMvX DTP is added to your automatic Total Plan monthly renewal.

Q-LawE Users

- vPortal Account (Master Service Agreement)
 - You should have a vPortal account and an executed user agreement.
- vExchange Mailbox
 - Your Total Plan subscription already includes a vExchange Mailbox.
- The vExchange DTP for Q-LawE is QvX
 - QvX DTP is added to your automatic Total Plan monthly renewal.

Q-Law Users

- vPortal Account (Master Service Agreement)
 - You should have a vPortal account and an executed user agreement.
- vExchange Mailbox
 - Your Total Plan subscription already includes a vExchange Mailbox.
- The vExchange DTP for Q-Law is the YGC DTP
 - YGC DTP is available for purchase on vPortal.
